	by Denmark and the Netherlands	
Case Denmark	A driver from Uzbekistan is employed as a substitute driver by a Latvian employment agency. The Latvian employment agency sends the Uzbek driver to a transport haulier which is established in an EU-Member State. Since the driver is from a third country, a driver attestation is required.	
Country	Questions	Answers
Austria	Do you ask for the contract between the employment agency and the transport undertaking in your country in relation to clarifying whether social dumping is taking place?	I cannot answer questions on social/labour issues as they fall within the competence of the Federal Ministry of Labour and Economy.
	Do you consider that the Uzbek driver first must have a driver attestation issued in the Member State where he is actually employed (i.c. Latvia), before coming to your country and/or other Member States?	We would consider that the driver must have a driver attestation for the Member State where the company is located that he is put at the disposal of, i.e. in this case Austria rather than Latvia, because the driver attestation is supposed to certify the legitimacy of the conditions of the driver's employment as regards the conditions set forth in Article 5 paragraph 1 relating to social dumping (e.g., the application of the relevant collective agreement).
	Are you of the opinion that the driver must have a driver attestation for each Member State or do you believe that a driver attestation from the country of registration of the driver employment agency is valid and must be recognized by other Member States where the driver is employed?	Consequently, we would consider that the driver must always have a driver attestation pertaining to the company the driver is put at the disposal of rather than the employment agency.
	Fines for driving without driver attestation

It must be checked that the agency employs the temporary worker correctly according to the standards in force in the carrier's country.

Latvia), before coming to your country and/or other Member States?	No, surely a driver attestation cannot be issued in the name of the (Latvian) employment agency? The driver attestation must be in the name of the transport company to whom the driver is posted.

Yes, if the driver is successively put at the disposal of several transport undertakings, a driver attestation will have to be drawn up for each of them. Each time, the wage and working conditions of the Member State where the transport undertaking is established will have to be complied with.

Denmark	Do you ask for the contract between the employment agency and the transport undertaking in your country in relation to clarifying whether social dumping is taking place?	<p>For us to approve an application to run a temporary driver agency, the temporary driver agency must confirm that they will pay the temporary drivers according to the Danish regulations. The problem is that we cannot check this until we request a contract.</p> <p>In cases where there is no temporary driver agency involved, we request the employment contract between the third-country driver and the Danish haulier.</p> <p>In cases where there is a temporary driver agency involved, we have not yet clarified whether we can request a copy of the employment contract regarding the relationship between the third country driver and the Latvian employer, or whether we can and should request the contract between the employment agency and the transport undertaking to clarify that the haulier legally uses the driver who is legally put at their disposal.</p>
	Do you consider that the Uzbek driver first must have a driver attestation issued in the Member State where he is actually employed (i.c. Latvia), before coming to your country and/or other Member States?	We believe that the third-country driver must have a driver attestation available from all the transport undertakings for which he operates.

		<p>In Denmark the employment agency has to have a Community licence to be approved as a temporary driver agency, but the temporary driver agency is not necessarily a haulier that actually carry goods by road for hire.</p> <p>The real employment relationship does not transfer from the temporary driver agency to the transport undertaking, as the temporary driver agency only make the temporary driver available to the Danish haulier for a shorter period.</p> <p>This question is also relevant because of the finding of whether the third-country driver is neither a national of a Member State nor a long-term resident within the meaning of Council Directive 2003/109/EC of 25 November 2003 concerning the status of third-country nationals who are long-term residents.</p>
	Are you of the opinion that the driver must have a driver attestation for each Member State or do you believe that a driver attestation from the country of registration of the driver employment agency is valid and must be recognized by other Member States where the driver is employed?	<p>We believe that each member state must decide whether the driver is legally employed by or lawfully put at the disposal of the transport undertaking in accordance with the rules in each Member State.</p> <p>Therefore, we believe that the third-country driver must have a driver attestation available from all the transport undertakings for which he operates, issued by each of the Member States where the transport undertakings are registered.</p> <p>We believe that this is the case, regardless of whether the third country driver is employed by or lawfully put at the disposal and used by the haulier in accordance with Danish laws.</p>

	<p>clarifying whether social dumping is taking place?</p>	<p>authority of the Member State of establishment of the haulier must determine, when issuing the driver attestation, that the driver (from third country), who is put at the disposal of the haulier, carries out transport operations in accordance with the employment conditions in force in that Member State. Therefore, in case an Estonian haulier hires a driver who works at an employment agency established in another Member State and applies for that person driver attestation in Estonia, then the competent authority issuing driver attestations in Estonia must ask from the haulier the rental contract which is concluded between that haulier and the employment agency under which the driver is put at the disposal of the Estonian haulier. Submitting such a rental agreement to the Estonian competent authority is an obligation. In addition, the competent authority issuing the driver attestation in Estonia will contact with the Estonian Labor Inspectorate, which makes an inquiry about this hired person through the IMI system to the Labor Inspectorate of the Member State where the employment agency is located, in order to verify the fact that the hired person really works in that employment agency and asks also whether this employment agency has the right to engage in labor rental activities in that Member State. This procedure ensures that the driver attestation is issued for the driver who is legally put at the disposal of the Estonian haulier.</p>

According to Regulation 1072/2009, a driver attestation is not issued to an entrepreneur who does not have the Community license. In Estonia, a driver attestation is also not issued to an undertaking that does not have the Community licence and any certified true copies of the Community license. As a rule, the employment</p>

		agency does not have the Community licence.

Assuming that the Chief Inspector of Road Transport receives an application from a Polish entrepreneur for the issuance of a driver's attestation for a citizen of Uzbekistan and it's accompanied by documents confirming the employment of the driver by a temporary work agency on the territory of Poland, the application must be accompanied by a cooperation agreement concluded between the temporary work agency and the applying entrepreneur. The contract is analysed in terms of the compatibility of the data of the driver and the applying

		entrepreneur. Social issues are not analysed in this procedure.
